Getting Your Ducks In A Row

Who needs a will? Apparently not Peggy, who has all her ducks in a row. . .

Last fall, at the Health Ministry's End of Life Workshop, Peggy Fish gave a presentation on "Getting Your Act Together." Peggy, a long-time friend of Dan and Susie's, has thoughtfully prepared many details for her brother, who will be in charge of taking over her affairs when she is no longer able to do so. For Peggy, who keeps defying predictions of how long she can live with the cancer diagnosis she has received, it made sense to care for the details.

Suzanne K. has thoughtfully taken Peggy's information, and with some other information, has compiled a packet. Copies of it are on the Health Ministries table, or can be obtained from Suzanne or Lee. Look for the picture of the little girl with all her ducks in a row.

The Table of Contents:

Funeral choices Home Utilities Insurance Financials Pet Information Bequests List of Friends and Family to be notified Stuff up for grabs

Pastor Wade would really appreciate each of us filling out the "Funeral Service of Witness for the Resurrection" form to keep on file at the church. It includes places to enter your chosen Scripture passages, favorite music, musicians you want, designated charity in lieu of flowers and other information that will make planning your celebration of life service less stressful for those who are charged with that task.

It is suggested that along with a copy of that form, you place the rest of the information in a colorful binder or folder. Suzanne chose a bright pink binder, easy to spot. This is a handy place to keep information: Do you own or rent your home? Who holds the mortgage or who is the landlord to contact? There are also reminders to notify utilities, housekeeper, lawn care person. . .You get the picture.

Who is your insurance agent? To which bank do you make car payments? What happens to your pet(s)? Or, for that matter, what happens to your minor children? Who does your taxes? What pensions do you receive? What automatic withdrawals come from your accounts?

What about your stuff? Have you designated who gets the family Bible or the heirloom clock?

A list of family and friends to be notified in the case of your death will save someone much time weeding through your address book or cell phone contacts list. That is, if you remember to keep it up to date.

Suzanne has also thoughtfully provided a copy of the Illinois Statutory Short Form for Power of Attorney for Health Care.

If you wish, pick up a packet at the Health Ministries table. If you pick one up, the best idea is to fill it out right away to the extent that you can. . .rather than putting it in a pile of stuff for someone else to take care of later!

Easy Butternut Squash

1 butternut squash

1 t. oil

Cut off the stem of the butternut squash. Cut the squash in half "from pole to pole." Use a spoon to scrape out the seeds.

Oil the bottom of a 9X13 pan. Place squash halves in it, cut side down.

Bake at 350 degrees for about an hour, until the neck end of the squash gives to your touch.

Remove from oven. Invert squash to cool. Scoop out the "meat." Sprinkle with savory or sweet seasonings:

salt, pepper, basil or oregano or honey, cinnamon, nutmeg, cloves or pumpkin pie spice

It is that time of year again. Someone may ask you to serve as an elder or a deacon. We hope you will listen and give the request some prayerful consideration. We are each given a spiritual gift to be used

"for the common good" (1 Corinthians 12:7). We, as a congregation, are given the gifts we need to carry on ministry in this place. Gifts mentioned in Scripture are hospitality, generosity, teaching, preaching, administration, and healing. However, the Spirit is not limited to any particular list of gifts and is constantly at work in our congregation and beyond us, drawing and cultivating gifts needed for the mission and ministry here, in this congregation.

We need people that know the kids by name, we need people to greet visitors and new members, we need people to deal with money. We need people to teach Sunday School and SHARKs. There are people who have never taught a Sunday School class but as soon as they volunteer because there was a need, they find they are given what they need and find that teaching is a joy. This is the Spirit as work empowering the ministry of ordinary church members.

Out of this understanding of ministry as a part of our church membership comes the practice of electing and ordaining officers - elders and deacons - to carry out particular tasks in the life of our church. Elders are set apart, along with our Pastor, to lead and govern the church. Deacons are set apart for ministries of compassion and service. "The existence of these offices in no way diminishes the importance of the commitment of all members to the total ministry of the church. These ordained officers differ from other members in function only." (The Book Of Order)

Just as Jesus set the example by washing the feet of the Disciples, we are called to the ministry of church officers, or as Sunday School teachers or leaders of SHARKs, along with that of all Christians, to carry out the imitation of Christ, who showed his love by serving.

"A Modern Parable"

The treasurer of a congregation in one of the western states resigned. The elders asked one of the members who was the manager of the local grain elevator to take his place...He agreed under two conditions. 1. That no report from the treasurer be asked for one year. 2. That no one ask him any questions during this one year period.

Since he was a trusted man in the community and most of them did their business with him as manager of the grain elevator, they agreed with this arrangement. At the end of the year he gave this report: The indebtedness of \$25,000.00 on the church was paid. The parsonage had been redecorated. The minister's salary has been increased. The mission quota was doubled. There were no outstanding bills and a cash balance of \$12,500.00.

The amazed congregation asked how this was accomplished. Quietly he answered, "Most of you bring grain to my elevator. As you did business with me, I simply withheld 10% on your behalf and gave it to the church. You did not even miss it. Now you see what we could do for the Lord if we were all willing to return the first portion to Him, who really owns it?"



Social Justice Team

The Social Justice Team would like to offer a series of biographies of great American heroes who are persons of color. Unfortunately, we did not learn about many of these individuals in our high school history classes.

Ida B. Wells



Ida Bell Wells-Barnett, more commonly known as Ida B. Wells, was an African-American journalist, newspaper editor, suffragist, sociologist, feminist, and an early leader in the Civil Rights Movement. She was one of the founders of the National Association for the Advancement of Colored People (NAACP) in 1909.

Ms. Wells was born in Holly Springs, Mississippi in 1862 a few months prior to the Emancipation Proclamation. Her parents were slaves of a prominent architect and she was one of 8 children. After the Civil War, her father became a master carpenter and fought

hard for the advancement of black people. He encouraged Ida and his other children to attend college. Tragically in 1878, Ida lost both of her parents and a younger sibling to yellow fever. Ida fought to keep her siblings together (instead of placed in foster care) by going to work as a schoolteacher. As a black teacher, she earned \$30 a month while her white peer teachers earned \$80 a month. This discrimination made her more determined to fight the discrimination in how blacks were treated.

In 1884 a Memphis train conductor ordered her to give up her paid for first class ticket to move to the overcrowded smoking car. This was 70 years before Rosa Parks. She sued the Memphis train system and won a \$500 settlement. However the next year, the Tennessee Supreme Court over-turned the lower court ruling and even ordered Ida to pay court costs. She was very disappointed with this ruling and wrote in response, "O God, is there no justice in this land for us?" She then became a noted journalist advocating for "justice for all" especially for African Americans and women.

In 1889 three black men who were close friends of Ida's were lynched following a white mob attack on the black men's grocery store in Memphis. From that point forward, Ms. Wells began to investigate all the incidents of lynching and found that they rarely occurred as a consequence of crime but they seemed to occur during times of economic depression and increase in black population. In 1990 her findings were corroborated in an influential study on lynching in America. This 1990 study (entitled the Beck and Tolney study) found that the rate of lynchings was higher when marginal whites were under threat because of uncertain economic times.

Ms. Wells freely acknowledged her personal flaws in particular her being quick to criticize and use harsh words. However her courage and crusade for the truth were how she should be remembered. In 1909 she became a co-founder of the NAACP.

Ms. Wells spent her later years working for urban reform in Chicago as well as raising her family of 4 children and 2 stepchildren with her husband, attorney Ferdinand Barnett. She died in 1931 at the age of 68. Since her death, her legacy has grown. Her homes in Chicago and Mississippi have become African American museums that act as cultural centers of African American history. There have been plays written about her life, a commissioned portrait of her hangs in the Harvard Kennedy School and there is a Foundation established in her name to protect, preserve and promote her legacy.

POLICY

It is the policy of First Presbyterian Church that a Board of Deacons be formed and made up of Deacons elected by the Congregation.

The description of a Deacon is found in G-2.0201, Deacon Defined, of the Book of Order.

The ministry of deacon as set forth in Scripture is one of compassion, witness, and service, sharing in the redeeming love of Jesus Christ for the poor, the hungry, the sick, the lost, the friendless, the oppressed, those burdened by unjust policies or structures, or anyone in distress. Persons of spiritual character, honest repute, exemplary lives, brotherly and sisterly love, sincere compassion, and sound judgment should be chosen for this ministry.

PROCEDURE

1. The Nominating Committee will suggest at an annual Congregational Meeting a slate of Deacons. Deacons will be elected in classes to maintain consistency on the Board of Deacons.

2. The Board of Deacons is made up of 6 Deacons each serving two year terms in classes of three Deacons.

3. A Deacon may serve up to six years concurrently and then must rotate off the Board of Deacons. (Per Book of Order)

- 4. The Deacons are a Ministry of Compassion and Service.
- 5. The ministry of the Board of Deacons is under the supervision and authority of the session.
- 6. The Deacons are responsible for the caring of those in need within the congregation.
- 7. The Deacons shall oversee any needed funeral meals. Assistance may requested from the Fellowship Committee and membership at large.

Nominating Committee

8. The Deacons shall oversee any special meals such as baby showers, hospitalized members family, and other special needs and may ask for assistance from the Fellowship Committee and membership at large.

9. The Deacons shall develop a care list of all members and regular attendees and others that need to be included. Each Deacon will be responsible for a portion of this list and be available to listen and help as needed. Deacons shall provide care including cards and or calls for such as shut-ins, those missing several weeks in a row and other needs as the Deacons shall outline.

10. The Deacons shall recognize the attendance of visitors and follow up as appropriate.

11. The Deacons may be asked to assist with the serving of Communion.

12. The Deacons may work with other committees as needs arise and duties overlap.

13. The Deacons should meet monthly.

14. The minutes of the Board of Deacons shall be available for the next Session Meeting.

15. A representative of the Board of Deacons shall report monthly to the Session. written or physical presence?

16. It is the responsibility of the Deacons to supply a single rose commemorating births in the congregation.

17. The Deacons will be responsible for the spending of all moneys for flowers.

18. To propose to the Session an amount to be included in the annual budget to accomplish the work of the Deacons.

19. Recognizing that moneys contributed through the quarterly green Deacons' Fund envelope should be treated as specified giving, Finance Committee shall set this money aside in a special account which will be available to the Deacons for use in their compassionate work over and above the budgeted moneys. Also, that any balance in this account at the end of the year should be carried over to the next year.

The pastor is available to serve as a resource person and to meet with the committee when invited.

POLICY

It is the policy of First Presbyterian Church that a Session be formed and made up of Ruling Elders elected by the Congregation.

Membership and responsibilities are found in G-3.02, THE SESSION, of the Book of Order.

The description of an Elder is found in G-2.03, RULING ELDERS, of the Book of Order.

Nominating Committee

PROCEDURE

- 1. The Nominating Committee will suggest at an annual Congregational Meeting a slate of Ruling Elders. Elders will be elected in classes to maintain consistency on the Session.
- 2. The Session is made up of Six Elders each serving two year terms in classes of three elders.
- 3. An Elder may serve up to six years concurrently and then must rotate off the Session.

4. The Session consists of members, ordained as Ruling Elders of the church, and each will chair and report for one of the following Committees:

- a. Budget Committee (Session as a Whole)
- b. Christian Education
- c. Mission/Communication
- d. Properties/Buildings and Grounds
- e. Spiritual Life
- f. Stewardship/Finance
- g. Personnel (Session as a Whole)
- h. Worship
- i. Each committee may have subcommittees. (These are listed under the Policies of each committee)
- j. The Session shall elect a commissioner to attend Presbytery on a rotating basis.

SESSION BEHAVIOR

1.Remember you are part of a working Body of Christ. Give everyone a chance to be heard.

2.Remember to disagree with issues, not with people.

3.Be constructive in your criticism

4.No personal attacks

5.Be loving and thankful for others

6.Remember we are working together to build the church.

7.Be sure to listen with an open mind

8.We don't gather already knowing God's will; we gather to seek it together

9.Remember to seek unity and purpose

10.Begin discussions with points of agreement

11.Explore alternatives and third ways

12. Remember to be involved in our work, but don't lose your sense of perspective.

13.Remember to keep your sense of humor.

14.Remember to stand up firmly for essentials, but remember also to know the difference between essentials and nonessentials.
